- Develop and design data collection systems, tools, and techniques.

- Prepare an annual action plan for the MLE department incorporating the targets of the MLE department.
- Support team members in executing M&E systems and processes, and provide M&E-specific capacity-building and mentoring as needed.
- Conduct capacity development programs of MLE related topics (trainings, workshops and seminars etc.)
- Conduct and support in endline/baseline/evaluation and develop reports at the project levels

Implementation of System

- Provide guidance-based support to project teams, and implementing partners on implementing MEAL framework/plan.
- Undertake field visits to monitor project implementation, identify bottlenecks, and provide feedback for improvement.
- Ensure execution of internal/external assessment (baseline, mid-term, and final evaluation) and ensure quality methodology and analysis as well as timely delivery.
- Support and guide to ensure the quality delivery of assessment reports (baseline, assessment, evaluation, etc.) conducted internally or externally.
- Conducted/Guided/coordinated project managers on monitoring and review meetings of the projects and initiatives.

Research, Survey and Assessment
